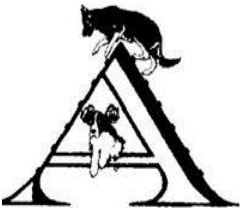

Waiver, Assumption of Risk and Agreement to Hold Harmless

Agility Club of San Diego, Inc

I understand that attendance at an Agility Club of San Diego, Inc (hereinafter referred to as the "Club") sponsored function is not without risk to myself, members of my family, and person(s) accompanying me, or my dog. That some of the dogs to which I will be exposed, may be difficult to control and may be the cause of injury even when handled with the greatest amount of care. I also acknowledge that there is an inherent risk in utilizing any type of training or sporting event equipment selected for such purpose, especially that designed and used for the sport of agility.

I hereby waive and release the Club, its members, officers, and agents from any and all liability of any nature, for injury or damage which I, any member of my family, any person accompanying me, or my dog may suffer, including specifically any injury while attending any Club function or while on the training grounds or the surrounding areas thereto.

I hereby agree to indemnify and hold harmless the Club, its members, and officers from any and all claims or claims by any member of my family, or any other person accompanying me to any function of the Club, or while on the grounds or the surrounding areas thereto, as a result of any action by any dog, including my own. I expressly assume the risk of any such damage or injury while attending any Club sponsored function.

I also agree to indemnify and to hold harmless, the Club, its members, and officers and shall personally assume any and all responsibilities and liability for any loss or injury which may be alleged to have been caused directly or indirectly to any person, dog, or property by the act of my dog, myself, my family member or any other person accompanying me while participating in a Club sponsored function, held at any training field or event grounds, or any other site selected for a Club function including surrounding areas thereto.

I also understand that it is my personal responsibility to maintain control of any dog in my care and custody while attending any Club sponsored function. Any injuries that my dog inflicts on another person or dog are also my responsibility.
